**216. Public Transport in the area**

a. Youth Cllr Saunders presented a comprehensive survey of those at school showing what modes of transport were used. Youth Cllr Gill offered to assist Youth Cllr Saunders in his further investigations and to liaise with Mr Corbett about when a car free day could be held. It was noted that as well as students getting lifts to school some 6<sup>th</sup> formers also drove themselves and this, together with staff cars, was also an issue to address.

b. The item concerning the public transport group was deferred in the absence of Cllr Gillmor.

c. Youth Cllr Saunders advised that there appeared to be problems with the 550 and the Clerk agreed to report this to Cllr Gillmor for the public transport group to investigate.

**217. Policing in Pershore**
